

Nation of Men, Inc. is a [nonprofit] corporation (hereinafter "NOM") that is organizing and hosting the Circles of Men V (hereinafter, "COM V") event. NOM is dedicated to supporting men, families and community. However, we all live in a modern world that includes the possibility of claims and litigation against NOM and the organizers of the COM V. Such claims and litigation would be a costly and time-consuming process that would undermine the continuation of NOM. Thus, we ask you to read and sign this waiver of liability.

VOLUNTARY PARTICIPATION

I acknowledge that I have voluntarily registered to participate in the COM V to be held on June 3 through June 5, 2011 at the Scout Camp in Boulder Creek, California.

ASSUMPTION OF THE RISK

I know and understand that the COM V is an event that may involve strenuous activities and sports, each of which independently or in any combination with other activities or sports, carry significant risks of serious personal injury, death, and property damage. I also know that during participation I will be exposed to many natural, mechanical, and environmental conditions and risks, which independently or in any combination with others may cause property damage or bodily injury including severe or fatal injuries to myself or to others. I know that these natural conditions and risks may include exposure to poison oak and other forms of wildlife. I understand that not all of the risks associated with the activities occurring during the weekend are known or predictable. I know and agree that I alone am responsible for my proper preparation and safety while participating in COM V, including but not limited to providing and utilizing proper equipment for all activities. I also represent that I have no physical or medical condition that to my knowledge would endanger others or myself while I participate in the activities of COM V. I am voluntarily participating in these activities with full knowledge of the risks involved, and I hereby agree to accept any and all risks of harm that may result from these activities.

RELEASE

As a condition for being permitted to register for the COM V and to participate in its activities, I acknowledge that NOM and the organizers of COM V are in not in any way responsible for my safety while I am participating in COM V. I agree to waive, release and discharge for myself and for my heirs, assigns, executors, administrators, legal representatives and successors in interests (hereinafter "successors") any and all claims of damages for death, personal injury, or property damage which I may have or which may hereafter accrue to me as the result of my participation in COM V, against NOM board of directors and officers, any and all event managers, organizers, volunteers, officials, sponsors, agents and/or employees of COM V (hereinafter "organizers"), whether or not such injury or damage was the result of negligence or carelessness on the part of the organizers and whether or not such injury or damage was foreseeable or not. Such injury or damages includes but is not limited to loss, claims, costs, expenses, attorney's fees, damages, and obligations of whatever nature whether known or unknown, suspected or unsuspected, predictable or unpredictable, arising directly or

indirectly out of my participation in COM V. I further agree to forever hold harmless and indemnify any and all organizers of COM V, generally or specifically from any and all liability for death, personal injury or property damage resulting in any way from my participation in COM V. I agree for myself and for my successors that the above representations are not mere recital and that they are binding upon me and upon my successors.

ARBITRATION

I agree that any claim, controversy, or dispute relating to the interpretation or enforcement of this document and/or arising out of or relating to my participation in COM V shall be submitted to binding arbitration under the rules and regulations of the American Arbitration Association. The arbitration shall take place in San Francisco, California. I do hereby waive my right to bring an action before a judge or jury in any court and I understand that I am giving up my rights to discovery and appeal. Any award rendered in arbitration may be made into a judgment by any court of competent jurisdiction. I understand that if I refuse to submit to arbitration after agreeing to this provision, I may be compelled to arbitrate under the authority of the California Code of Civil Procedure.

I acknowledge that I am over the age of 18 years and that I have read and understood the contents of this document.
